

1. **“PATRIOT GAMES SEASON 2 PRIZE” PROMOTION**
2. TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is Patriot Productions Pty Ltd (ABN 25 614 388 582) of 1 Activity Crescent, Molendinar QLD 4214. Telephone: **07 5597 0638**
3. Entry is only open to Australian residents aged 18 years or over.
4. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter.
